| MOROCCO | DLM | Softgroup crossed downwards the participation threshold of 10%

Following the capital increase operation by incorporation of shareholders current accounts of DLM of an amount of MAD 15 Mn and reserved to some shareholders and board of directors members, Softgroup crossed downwards, due to a dilution effect, the participation threshold of 10% in DLM's capital. Following this transaction, Softgroup holds 135,544 DLM shares, representing 7.75% of DLM capital (post capital increase).

Within the six months following this operation, Softgroup intends to continue its sales on DLM.

| CÔTE D'IVOIRE | INFLATION | An inflation rate of 5.7% in November 2022

According to Côte d'Ivoire's National Institute of Statistics, the Harmonized Consumer Prices Index recorded an increase of 0.2% in November 2022 compared to the previous month. Year-on-year, the inflation rate stands at 5.7%.
