| MOROCCO | AFRIC INDUSTRIES | Revenue down 21% in Q1 2026

In Q1 2026, Afric industries' revenue amounted to MAD 8.5 Mn against MAD 10.6 Mn during the same period of the previous year, recording a decrease of 21.2%.

| TUNISIA | FOREIGN TRADE | Figures at the end of April 2026

During the first four months of 2026, Tunisia's exports increased by 9.5% to TND 22,694 Mn. Likewise, imports rose by 7.9% during the same period to settle at TND 30,223 Mn. In this context, the trade deficit went from TND -7,293 Mn at the end of April 2025 to TND -7,529 Mn at the end of April 2026. Finally, the coverage rate stood at 75.1%, up 1.1 pt.
